\*\* All-State applications are to be completed online at <u>NYSSMA.org</u>. Applications must be submitted 6-weeks prior to the all-state audition (same deadline as registering for the festival). Students must also still be registered through <u>DaCapoMusicFestivals.com</u> for the festival. Students registered as an all-state student without an application will not be allowed to audition for all-state!

## Why become an adjudicator?

- The orientation helps you understand the NYSSMA evaluation process.
- You become a better teacher because you understand what the adjudicators are looking and listening for.
- You have knowledge to offer to younger musicians (you teach students and prepare them for festival, you are able to evaluate students and provide feedback).
- Professional responsibility you give back to help inform other students and teachers.

## Adjudicator Orientation - Frequently Asked Questions

Q: Do I have to pay for the hotel room and then be reimbursed?

A: No. NYSSMA will arrange and pay for the hotel room. The hotel may require you to provide a credit card for possible incidental expenses (which are not covered by NYSSMA).

Q: If I am staying at the hotel, may I check in early before the seminar?

A: Yes. Please contact the hotel for check-in times and policies.

Q: Are the hotel rooms single?

A: Yes, unless you pre-arrange to room with another candidate.

Q: I have an engagement on one of the days. May I leave early or show up late?

A: No. NYSSMA and the Adjudication Festival Committee require you to attend the entire seminar to be successfully oriented.

Q: Do I need to prepare a selection for performance, or bring an instrument to demonstrate proficiency? A: No. The orientation seminar is focused on learning to evaluate student performances through the NYSSMA evaluation rubric. Demonstration of your personal performance skills are not required.

*Q*: *Will I be working with students?* 

A: All-State, Second-Area and Major Organization candidates will not work with students. Regular candidates (new adjudicators) will run actual festival evaluation rooms and will work with students.

# INTEGRATION TABLE FOR SOLO SHEETS NYSSMA - ZONE 2

This **Zone 2** integration table for solo sheets is intended to present the most thorough and complete integration table possible for all score results. It is not intended to be the only component for selection into an Area All-State ensemble. In addition to this integration table the selection committee will use teacher recommendations to produce a balanced, ability appropriate, Area All-State ensemble for the selected festival literature.

All State Level 6 scores that fall at or below the 96 mark will be considered one step above their Level 6 equivalent in the integration table. The Area All-State selection committee will not consider nominations with a score of 20 or less on Levels I-IV; a score of 89 or less on Levels V-IV.

This integration table will be used for all Area All-State ensembles *except* for Jr. High Chorus.
